Dear Mrs Braidwood,

Thank you for your email.

I can advise that an application has been submitted under ref: 20/04301/FUL to regularise the unauthorised fencing at the front as well as proposed further alterations. Due to a backlog of applications and the Christmas break my colleague, Ben Bendall, has not yet been able to validate the application. However, please be assured that the application will be assessed on its merits and in accordance with the relevant planning policies and that there is also no guarantee that permission would be granted. Additionally, once the application is validated the Parish Council will have an opportunity to formally comment on the scheme.

I apologise if you consider that this case has not resulted in a satisfactory outcome but can assure you that the case is still open pending the determination of the planning application. Please note that it is accepted practise that, if an application has been submitted, formal enforcement action is held in abeyance until a planning decision is made.

Dear Mrs Braidwood,

I must apologise for the lack of update with regards to your complaint regarding the erection of fencing at Wychwood, Preston. I can, however, advise as follows.

The new fencing erected to the front of the property was considered to require planning permission by virtue of its height being over 1m and adjacent to a highway. The owner employed an agent to submit an application in an attempt to regularise the unauthorised fence. Unfortunately there have been a few delays with the submission of the application but I can advise that an application has been submitted for the fencing along with some further alterations which has been given the reference 20/04301/FUL. The application does not yet appear valid, however, once it has been validated I shall be in contact to advise so that the Parish Council have an opportunity to provide formal comments. Please note that any application would be assessed on its merits and in accordance with the relevant planning policies. There is also no guarantee that permission would be granted.
