I refer to our previous correspondence and conversations about this application as well as Cllr Stone's email to you dated 2 October. The Parish Council would like you to be aware of just how unhappy

and disappointed it is with CDC's handling of the many planning applications for this site at Wychwood in Preston.

In fact, it is quite worrying that the applicant has been allowed to avoid compliance with procedure and ignored requests for action. To make matters worse, CDC Planning Department does not appear to have any explanation as to why and how this has happened.

As Cllr Stone has pointed out, there seems to be no correlation between Decision Notices and the corresponding applications to the point where we are completely confused about what has been approved and what has not. This, in particular, is the case with the cladding of both the house and the garage.

As you are aware, the Parish Council has been very concerned about the front boundary fence for which an application is still awaited after well over 12 months with no apparent Enforcement action. It is not only an eye sore, it also contravenes Design in Preston and CDC's own Cotswold Design Code. Bearing in mind how applications for this site have been handled to date, you must be able to understand how concerned the Parish Council is and its fears that this will just be another thing allowed to remain without explanation.

The Parish Council is now seriously looking for your help and support in resolving this matter.
