

PRESTON PARISH COUNCIL

MINUTES OF THE MEETING HELD ON THURSDAY, 11 SEPTEMBER 2014

PRESENT: Cllr Mrs C Sutton (Chairman), Cllr Mrs J Tomblin (Vice-Chairman), Cllr Mrs S Cameron, Cllr Mrs P Chester-Master, Cllr G Edwards and Cllr Mrs R Freyne.

ALSO IN ATTENDANCE: Mr G Handley (Road Safety Manager, Road Safety – Gloucestershire), Cllr N Dummett (CPRE), Mr J Lynn, Cllr S Parsons (GCC) from 7.15 pm and Mrs C Braidwood (Clerk)

Mr G Handley, Road Safety Manager, Road Safety – Gloucestershire

- Mr Handley explained that he works as part of a Partnership with the Police, Fire & Rescue.
- The Partnership has recorded road injuries data for the last 40 years and use it to evaluate whether road safety measures are working.
- Collision Data is accessible on GCC website – road safety
- Last year had the lowest road injuries figure ever.
- All accidents are due to driver error and the aim is to change attitudes by retraining speeding motorists.
- Speed is public enemy no 1 and it is drivers' responsibility to drive within the limit.
- 78% motorists regular exceed 40 mph limit.
- Need to change the attitude of local drivers first and gave examples where communities had been successful.
- The Partnership can lend monitoring equipment for residents to use
- By creating 'Intrigue and Uncertainty' can effect mental traffic calming and influence drivers' choice by making them less comfortable.

Concern was raised that the Village has become a rat run for traffic since the road works have begun on Burford Road. It was further noted that the 30 mph repeaters are in wrong place and are **not** bold enough.

Mr Handley advised that when discussing issues with authorities, not to take 'No' for an answer and to ask questions when told that something is not possible or is illegal.

Cllr Parsons offered to help with a proposed traffic-calming scheme from the Highways Local Fund and recommended that any scheme under consideration should be discussed with him and Mr Handley.

3. Minutes

4. Matters Arising from the Minutes

Check of Vehicle Activated Sign at Toll Bar

The Clerk reported that no update has been received.

Cost of Replacement Village Sign

Richard Gray, Gloucestershire Highways had confirmed that a new sign would cost in the region of £150. Despite Highways refusal to install gates at each end of the Village, it was agreed to investigate plastic gates together with new signs requesting drivers to observe

Action: an advisory speed limit of 20 mph. The Clerk was requested to obtain samples for the

gates.

Re-modelling of Junction with Kingshill Lane

The comments of Road Safety were noted.

5. Reports from County and District Councillors

Cllr Shaun Parsons (County)

Following approval of the recent planning application to park HGVs in the Yard at the north end of the Village, Members raised concerns that the closure of the Cirencester Lorry Park may result in further requests to park on the farm yard site and that there will be an increase in HGV traffic through the Village. Cllr Parsons confirmed that 7.5 ton traffic is allowed on few roads except for access and that restrictions can be imposed where appropriate. He agreed to investigate a change in the limit. It was noted that Belectric had agreed that lorries delivering to the solar farm site would use Witpit Lane and not the

Action: Village road.

6. Mr N Dummett – CPRE

Mr Dummett explained that CPRE is a national organisation that aims to protect the countryside by lobbying the government about the planning system. CPRE is concerned with how something will affect the general public's enjoyment of the countryside and not individuals.

With regard to the proposed solar farm he made the following observations:

- Main objections would be impact on the landscape, principally from the bridge and bridle path, a little from Wit Pit Lane but not from further away.
- The solar panels will be angled towards the road (A417 - south) and, therefore, the aspect from the north will be minimal. A key point is to establish that the pathways and bridleway are well used.
- Planning has some protection for the best and most versatile agricultural land but this is not guaranteed. Members expressed concern that Belectric may have inaccurately claimed that the land is 3b and 4 and Mr Dummett agreed to try to find the official statistics for the site.
- Unfortunately, the site is outside the AONB.
- Will need to explain why the landscape is so important – open landscape that can be seen from public spaces and that if the site is hedged in, it will change the landscape.
- The proposal to plant mature trees on fast draining land will require maintenance and is high risk.
- Need to see the planning application but it is likely that CPRE will object because of the way the site sits in the landscape.

7. Questions from the Public

Mr Lynn asked questions relating to road safety that were answered by Mr Handley and reported above.

8. Playing Field

Play Area Refurbishment

Cllr G Edwards reported that he had met with a representative of one of the play equipment manufacturers and had obtained some prices. He had been advised to apply for grants from CDC and the Lottery. It was agreed that whilst the Council has a budget for play equipment it is unlikely to fund a great deal of equipment and that grants would be a sensible approach. It was noted that there are not many young children in the

Action: Village but quite a few visiting children. Cllr Edwards would report to the next meeting.

Replacement of Safety Surface underneath the Slide

The Clerk advised that she had been unable to progress this work and Cllr Edwards offered

Action: to replace the safety surface and repair the roof on the climbing frame.

Proposed Solar Farm Off Wit Pit Lane

Cllr Mrs Sutton and Cllr Mrs Cameron reported that they had met with Mrs A Pellegram to explore what help she could offer in relation to planning issues. Mrs Pellegram had recommended developing a Community Statement following a consultation exercise involving all residents. The Clerk was requested to contact CDC Planners to check that such a Statement would be of value and carry weight when responding to applications and Cllr Mrs Cameron would contact Mrs Pellegram to make initial arrangements to hold a consultation evening on Thursday 25 September.

Action:

Provision of Allotments at Kingshill Meadow

The Clerk reported that CDC Planners have confirmed that allotments will be provided on the site agreed during the planning process.

Public Rights of Way

It was noted that it is important to use the bridge path and other footpaths in the Parish to ensure that they are maintained and remain open. The Clerk was requested to notify PROW at GCC that the footpath notice, from the village street by the dog poo bin

Action: needs to be replaced and the footpaths on Village farm land need clearing and cutting back.

Provision of Public Noticeboard

The Chairman advised that Mr & Mrs Mingins have kindly agreed to a residents' noticeboard being fixed to their wall adjacent to the Village Hall. Cllr Edwards agreed to obtain a quote from Gary Kendrick & Spalding for an 8 x A4 size board.
