Thank you for the email and confirming acceptance of the name.

All local authorities following national guidelines when creating new addresses/naming new streets to ensure that all new addresses follow a set format. The guidance strongly recommends that punctuation should be avoided, as not all databases can accept it. Please see a link to the guidance below –

Based on the recommendation we therefore try to avoid the use of apostrophes in all new addresses to prevent any issues or discrepancies between different datasets and stop any confusion when addresses are given to call handlers in an emergency situation.
