4. **Co-Option to Fill the Vacancy**
Action: CB There has been no success to date to recruit another Councillor and it was agreed to advertise again.
5. **Reports from County and District Councillors**
Cllr Evey was unavailable and had sent a report (attached).
Cllr Spivey reported the following:
 - Local Plan consultation has been extended to 7 April and It was agreed that the PC should respond regarding retention of the Green Buffer zone between Cirencester and Preston; as well as emphasising the necessity of a foot and cycle way along Kingshill Lane giving access to the Schools.
 - Transport to School is a very difficult issue with £3.8 billion spent nationally. It was agreed that all Members should make a personal response and to email absent Councillors to ask them to also make a response.**Action: CB**
 - Planning local Highways work for 2025
 - There is still some money remaining in the Build Back Better fund if there are any suitable projects.
 - GRCC Village Hall funding will expire in July.
 - Lisa reported on the fundraising she has supported and offered to help the Council liaising with the Trustees of the Playing Field.
 - Tree roots on footway on Cirencester Road – the Chairman mentioned that she had seen a type of wet pour used around the roots of a tree in Oxford and Cllr Spivey agreed to investigate.
 - Richard Gray is to retire tomorrow and will be replaced by Gill Portlock.
 - Cllr Stone asked if footpath signs could show destinations ?

7. **Chairman's Report** – Cllr Mrs J Tomblin had nothing to report.
8. **Playing Field**
 - All is fine but the field is very wet and muddy.
 - Concern about the condition of the poplar trees on the boundary that are shedding following recent high winds and could be danger to passers-by. It was agreed to ask Cllr Price to check the situation. It was noted that some of the poplars in the spinney have been removed by electric company.**Action: CB**
