7. Chairman's Report

Cllr Mrs J Tomblin spoke about Mrs Scilla Chester-Master, the loss felt by the Parish Council and the huge impact her death will have on Village as a whole.

She also raised the matter of the funds received from Gridserve which are being held in reserve for an appropriate community project and explained how, at the last meeting, it had been proposed that these funds might be used to buy land for a Playing Field. The lease for the existing Playing Field runs out in 2026 and the Council had met with the leaseholders' Agent in November 2021 to discuss the way forward. The Agent had indicated that the leaseholders would be willing to renew the lease on the existing site or provide an alternative one in the middle of the Village. Since then, the Clerk has been unable to make contact with the leaseholders' agent in order to discuss the matter further. Mrs Regine Freyne, who, when a Member of the Council, had been instrumental in securing the funds, is supportive of the suggestion to invest in land for a Playing Field.

All Members present agreed with the proposal in principle and it was agreed to continue to try to make contact with the Agent, in the first instance. If this fails then an approach should be made to the leaseholder, Abbey Farms Trust, direct.
